

REQUIREMENTS, DEADLINES & GUIDELINES

- 1. Requirements & Deadlines a. Competition registration Deadline is July 7th 11:59 pm EST.
- b. To enter the competition, you must be registered in OBC with one of our packages: a ONE DAY PASS, a VIP PACKAGE or an ELITE VIP PACKAGE. This also applies to each member of a troupe in the Group Category.
- c. To complete registration, you must be registered in OBC with the package of your choice, pay the Competition Registration Fee, sign and send the Registration Form and sign and send the Artist Release.
- d. For Group Registration, send us an email with the number of members and we'll send you an invoice. e. All members of the group must sign the artist release.
- f. The following must be sent to orlandobellydanceconvention@gmail.com by July 12th 11:59 pm EST. Music in MP3 format properly labeled. Please, indicate your Name, Competition Category, Choreographer, and Music Title and Artist. If you will start ON or OFFSTAGE If you'll use props and which props if so Costume color
- 2. Guidelines
- a. Must be dressed and ready at least a half-hour prior to your scheduled competition time.
- b. Must wear a cover-up when outside of the dressing room.
- c. Points will be deducted if music runs overtime.
- d. The choreography must be original in the Professional soloist categories. No choreographies learned from other artists or instructors.
- e. No personal assistants or helpers are allowed back-stage or in dressing area.
- f. You must remain on stage during your entire performance.
- g. Judges' scores are final.
- h. Competition registration is non-refundable and non-transferable.
- i. If there are no more than 3 registered contestants, the competition will be canceled.
 Contestants already registered will have the option to perform and get feedback from judges.
 NO PRIZES will be offered if competition is canceled.
- j. You will be able to purchase pictures and videos of your performance. Please, no unauthorized videography or photography allowed during any shows.



- k. We reserve the right to modify the date, prizes or time of the competition prior to the competition. The competitor will be informed. We reserve the right of admission.
- I. We are not responsible for lost or stolen articles.
- m. No flame or nudity and no live animals in any category.
- n. Not following these rules will result in disqualification.
